**MAGISTRATES (COMMUNITY COURTS) (NEW PROVIDENCE) ORDER 2009***S.I. No. 64 of 2009*

*[Commencement - 1st July, 2009]*

**(SECTION 11)**

**1. (1)** This Order may be cited as the Magistrates (Community Courts) (New Providence) Order, 2009.

Citation and duration.

**(2)** This Order shall come into force on the 1st day of July, 2009 and shall expire on the 1st day of July, 2010.

**2.** The justices of the peace named in the First Schedule are empowered to try cases singly within the district of New Providence, in respect of offences referred to in the Second Schedule and to hear such other matters as the Chief Justice may direct by notice, in writing.
